Microbes inside a gas line are a suspect in the explosion and fire in San Bruno, Calif., that killed seven people and destroyed 37 homes, officials say.

PTSD interrupts lives after trauma

According to the Diagnostic and Statistical Manual of Mental Disorders, a reference used by the American Psychiatric Association that includes all currently recognized mental health disorders, 8 percent of the American population suffers from some form of PTSD, though experts in the field say up to 15 percent of Americans do. Although soliders returning from war are more commonly known sufferers of PTSD, once called "shell shock" and "battle fatigue," PTSD can affect anyone who has suffered a traumatic event.

This includes witnesses of trauma, like the concertgoers who saw the suicide at the

Swell Season performance last month at the Mountain Winery in Saratoga, as well as those whose lives were directly threatened by crime or accidents, like the residents of San Bruno who were rocked by a massive PG&E gas explosion this month. Even experiencing a minor car accident can pull some people into the downward spiral of PTSD.

CA State Senate Majority Leader Florez seeks names of PG&E personnel who worked near San Bruno pipeline prior to blast

In an effort to determine the causes of the San Bruno gas line explosion and prevent future such trajedies, Senator Dean Florez is asking Pacific Gas & Electric and the California Public Utilities Commission to turn over hundreds of pages of internal documents to the state Senate

Arguing that PG&E failed to fix what it knew to be a potentially dangerous problem, the Senate Majority leader is also asking the utility to provide the names of PG&E personnel who worked in the vicinity of the San Bruno pipeline in the days prior to the blast.

In separate letters today to PG&E and the CPUC, Sen. Florez, D-Shafter, cites a pattern of concealment on the part of the utility and a pattern of lax oversight by the public watchdog.
