## San Bruno Media Update

#### Summary

This morning, media outlets reported on *The Los Angeles Times*' article about the number of leaks in PG&E's gas lines that run near metropolitan and environmentally-sensitive areas compared to national averages. PG&E has been reaching out actively to all media with the following information:

"We believe it is our responsibility to ensure our regulators have the most comprehensive information we can provide about our natural gas system, and we provide that to them. On HCA pipelines, we report everything from a pinhole leak to a third-party dig-in. We continue to work with PHMSA to determine how our self-imposed strict reporting requirements compare to our industry peers. It appears that article looks at less than a third of the total miles designated across the country as high consequence area pipeline. It is important to remember that high consequence area pipelines are defined by regulations and do not vary depending on the size of the operator. What we have found is that when we compare our statistics to ALL pipeline operators in the country, we are comparable to the industry standard.

Regardless of statistics, the tragic accident in San Bruno is devastating to us all. The 20,000 men and women of PG&E work day and night to provide safe energy service to our customers. Safety is our top priority. We take it personally, and we will continue to do everything we can

to help assure the people of northern California that our gas and electric systems are safe."

Bay Area broadcast stations also reported heavily that Congresswoman Jackie Speier (D-San Mateo) will be in San Bruno today and introduce new pipeline regulation legislation. The *Washington Post* also published an Associated Press article that reviewed pipeline legislation introduced in 2002 and noted that pipeline watchdog groups claim that industry lobbyists have pushed through relaxed regulation policies.

### **Developments to Date**

Congresswoman Jackie Speier is scheduled to meet with emergency response officials in San Bruno today and is expected to introduce legislation that would require more stringent pipeline regulation; media reports she will be meeting with PG&E later in the day

PG&E gas line leaks exceed national average By AP Staff (Information from LA Times) September 27, 2010 Records show Pacific Gas & Electric, whose pipeline exploded in San Bruno earlier this month, has reported gas line leaks at a rate six times the average for other large pipeline operators.

Federal records analyzed by the Los Angeles Times shows PG&E has reported 38 leaks since 2004 along about 1,000 miles of line it controls near population centers or environmentally sensitive areas.

The leak rate was 6.2 annually per 1,000 miles of transmission pipes serving "high consequence" areas, more than six times the average leak rate for the nation's six other large operators.
