Summary

The Los Angeles Times reported that the leak rate for PG&E's gas lines that run near metropolitan and environmentally-sensitive areas is six times higher than the national average. This story was republished by Sacramento Bee and picked up by several local broadcast affiliates in the Bay Area. The San Jose Mercury News ran a story, that appeared across Bay Area News Group papers, that calls into question the competency of the California Public Utilities Commission

(CPUC). Local and national broadcast outlets began airing stories about how the San Bruno community is planning to move forward and rebuild itself in the wake of the Sept. 9 incident.

Developments to Date

- It was reported that the leak rate for PG&E's "high-consequence" lines near population centers was more than six times the national average
- The CPUC will be under close scrutiny as it investigates the San Bruno incident, as oversight groups question its history of enforcement
- The San Bruno community begins to focus on how it will rebuild itself in the wake of the Sept. 9 incident

Reported leak rate for PG&E's 'high-consequence' gas lines far exceeds national average

The operator of a Bay Area gas pipeline that exploded in a lethal firestorm earlier this month has reported leaks on similar lines in populated areas at a rate more than six times that of other large pipeline systems across the country, according to a Times analysis.

Pacific Gas & Electric Co. has reported 38 leaks since 2004 along about 1,000 miles of line it controls near population centers or environmentally sensitive resources, federal records show.

San Bruno blast throws spotlight on state regulators

In the wake of the catastrophic Sept. 9 gas line explosion in San Bruno, the finger-pointing has begun to move beyond PG&E to the largely obscure, 99-year-old state agency that oversees the company, the California Public Utilities

Commission.

Officials with the 1,000-person PUC -- which regulates everything from gas and electricity suppliers to moving van operators and limo drivers -- speak proudly of the work they do. One local energy expert called the California agency perhaps the best in the nation at regulating utilities.

But critics contend the agency has a history of cozy dealings with utilities that raises serious questions about how well it was paying attention to the potential hazards lurking within PG&E gas lines. And recent reports have faulted the PUC for its handling of thousands of consumer complaints against the companies it monitors.
