A few hours before a Pacific Gas and Electric Co. natural gas pipeline ruptured in a San Bruno neighborhood, killing seven people, the utility had a problem with an important piece of equipment at the Milpitas operations terminal where the pipeline originated, federal investigators said Monday.

The National Transportation Safety Board, which is investigating the Sept. 9 blast, said PG&E crews had been working in the Milpitas terminal on replacing an uninterruptible power supply system, or UPS, which is designed to make sure that electricity remains constant in the event of a blackout.

House Bill to Tighten Gas Line Regulations is Introduced

Standing at the crater that marks ground zero of the gas explosion that recently devastated this community, Rep. <u>Jackie Speier</u> (D-Hillsborough) announced legislation Monday that would mandate stricter regulations of gas pipelines nationwide.

Among other requirements, the Pipeline Safety and Community Empowerment Act of 2010, which Speier plans to introduce Tuesday, would require the installation of automatic or remote shutoff valves in areas of high seismic hazard and on pipelines in other areas deemed high risk.

Federal investigators looking into the Sept. 9 gas line explosion in San Bruno said Monday that an important piece of electrical equipment failed just hours before a Pacific Gas & Electric Company transmission line ruptured, killing seven people, the Chronicle reports.

PG&E was working on replacing an uninterruptible power supply system, or UPS, at the Milpitas terminal where the gas line originated, according to Peter Knudson of the National Transportation Safety Board. The UPS is designed to maintain a constant level of electricity.

Speier Seeks Pipeline Reform By Bill Silverfarb September 28, 2010

U.S. Rep. Jackie Speier will introduce legislation today to strengthen natural gas pipeline regulation and oversight following an explosion and fire that destroyed a significant portion of a San Bruno neighborhood Sept. 9.

The bill will require automatic or remote shut-off valves on some transmission lines, disclosure of pipeline locations to homeowners, disclosure of emergency response plans to regulators and disclosure of integrity management plans to pipeline safety officials.

Speier, D-San Mateo, noted Pacific Gas and Electric's inability to shut off the gas for an hour and 46 minutes on the night of the explosion, putting firefighters on the defensive.
