Hi All,

In the past, and more so recently, the utilities have sought ED's opinion on various custom measures/projects for which they have been unsure of the approach that ED might use in evaluating such projects. ED provided early opinions for several projects as a courtesy to the

utilities. Each of these early opinion projects presented different Evaluation, Measurement and Verification (EM&V) or Energy Efficiency (EE) policy issues that utilities have questions about. The utilities have been emailing ED staff requesting this early opinion. Staff requests that IOUs now make their request for ED early opinion using Basecamp.
