**Subject:** PHC on the mobile homes issue?

Sepideh:

I realize that the Commission has bigger fish to fry at the moment, but we received notice today of an October 27th PHC pertaining to the mobile home parks issue. We're a bit confused by this, since the Commission has not put forth or voted on a PD to open a rulemaking just yet. It's our understanding that the PHC comes after the Commission opens a proceeding. In addition, reply comments on WMA's petition for rulemaking aren't due until the September 30th.

Although the Sempra Energy Utilities are supportive of a rulemaking and Commissioner Ryan's leadership on this issue, but not of a rulemaking in response to WMA's myopic set of issues, it would seem that noticing a PHC in a proceeding that hasn't been opened and in advance of reply comments on WMA's petition would be premature.

What is the Commission's expectation of the utilities for October 27th in the absence of an actual proceeding? For background, below is the notice that we received.
