Subject: Confidentiality of cyber-security meetings

All:

I have received the concerns raised about the ability to share confidential materials with CEC and CAISO staff as part of any cyber-security briefing. I have reviewed with our lawyer, and have notified the CEC and CAISO staff of your concerns. CAISO staff has stated a desire to sign any NDA in order to be part of the discussion. I have not received a final position from CEC staff, but with CAISO staff indicating a willingness to sign, it seems appropriate to ask the utilities how you would like to go forward in preparing a non-disclosure agreement for CEC and CAISO staff to be able to participate in a cyber-security briefing.

Additionally, the only date that has been suggested by any party to have a meeting is October 11. I do have a suggestion from CAISO that these meetings be held as close together as possible to limit travel from Sacramento, which is reasonable to

me. If the group on this email wants to propose dates, or at least share with the group which dates are available, that is fine with me.

Finally, I will attempt to come up with some proposed dates for the metrics webinars next week. Again, I am open to the utilities proposing some dates, but in the absence of that, I will propose some dates next week.
