Hi Mr. Deal,

Allow me to introduce myself. Kristen Murphy and I both recently returned from a program called the Transatlantic Renewable Energy Fellowship, in which we were placed at German renewable energy firms in order to facilitate knowledge transfer between Europe and the US. I was placed at a wind energy development firm in Potsdam, Germany. My past experience spans environmental science to wind energy development to strategic consulting at both small (e.g., a five-person new venture) and large firms (e.g., Iberdrola Renewables and BP Alternative Energy).

My experience to date has given me insights to various aspects of the bulk power system but I would like to gain more comprehensive experience by working for a utility. I also know that utilities (especially in California) face a huge challenge to both meet regulations and deliver low-cost electricity, and I would welcome the opportunity to be part of a team that crafts innovative solutions for its shareholders and customers. I should note here that I have done some independent study into the larger bulk power system including taking online courses through PJM.

I would certainly appreciate if you put me in contact with some folks at utilities but, if anything, I would appreciate the opportunity to hold an "informational interview" with you. Considering your position, I'm sure you have intimate insight into the special nexus between state government and electric power suppliers that exists in California. It was nice meeting you the other week at the FERC happy hour/Kristen's birthday celebration! I was at an event at the Swiss Embassy a couple days later and a colleague of yours, Matt Horowitz, gave a presentation about the state of the solar industry in the US. He had to run out right afterward, so I didn't get to properly meet him. Similar to the wind energy industry, it sounds like the solar industry has a lot of potential opportunities in the eminent future.
