I hope this note finds you well. When we last met up in Sacramento you expressed some interest in coming along with us to some of the community meetings that we are having as part of trying to improve the degree and pro-activeness of our community outreach. As such, we have been working with the Town of Fairfax on a plan to addressing the community's concerns. That included a session last week where PG&E was simply invited to listen to the community's concerns. That session lasted more than two hours and resulted in the questions that are attached. Our follow-up session with the community is scheduled for 9/29 where plan to cover the basics of SM deployment and RF issues. We anticipate that there will be a second session subsequently to cover other related issues such as privacy.
