

Summary

Coverage of PG&E continued to be very heavy this evening. Over the last 12 hours, there have been more than 300 news articles published to the web about PG&E's long-term project planning list ('the Top 100') released today. The following chart shows the spike in coverage came mostly in the early evening hours.

A. <u>California Officials Question PG&E On 100 Riskiest Pipelines</u> (WSJ)

The Los Angeles Times reported a spokesperson for Governor Schwarzenegger called upon SDG&E and So Cal Gas to release lists similar to PG&E's. *The San Diego Union-Tribune* reported SDG&E has stepped up inspections and outreach surrounding its major transmission lines. *The San Francisco Chronicle* published a story about how the families of San Bruno can help each other heal and KGO-TV (ABC) reported a story about pipeline locations raising concerns over property values. An article written by the Associated Press discusses federal regulators' and industry's reluctance to allow pipeline location information to be widely available to the public. PG&E was also mentioned in an *LA Times* article about political contributions. Media Relations also reached out to several newspapers that described the pipelines as high-risk, rather than priority pipelines in their headlines.
