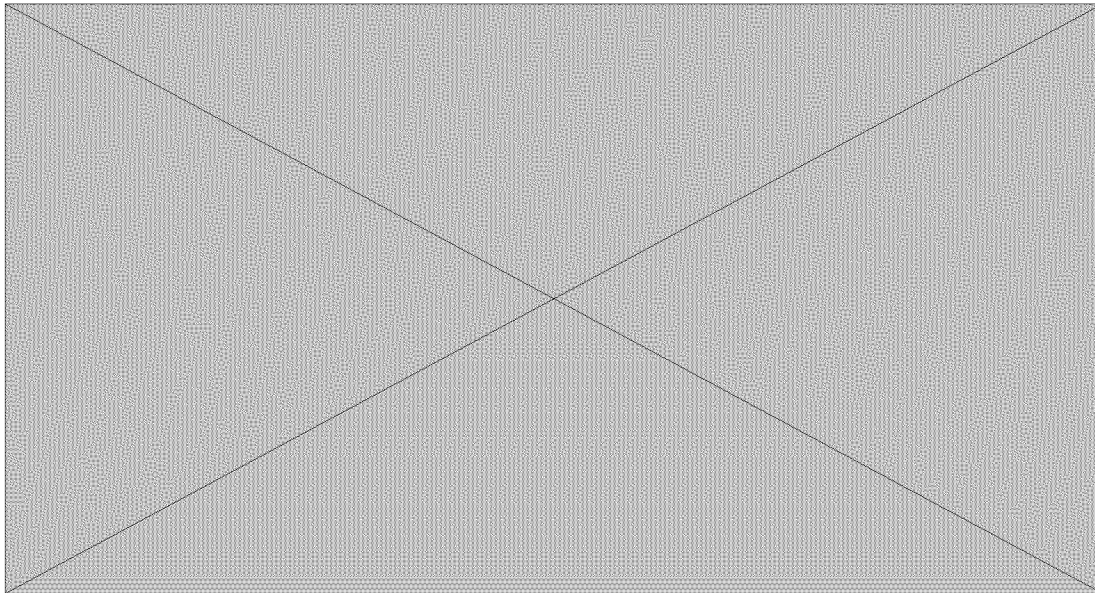
Transit and

Subject: DRA's Jacqueline Greig Feared Dead in San Bruno Explosion

The press is now reporting the feared deaths of our friend and DRA colleague Jackie Greig and her youngest daughter in yesterday's San Bruno explosion and fire. Jackie's husband James and older daughter were at a school event at the time, and are safe.

Although there's still no official confirmation, I'm afraid we must prepare to accept the worst.

The many, many people who knew and loved Jackie grieve with her family. In her over 20 years with us here at the PUC, Jackie's quiet strength, great intelligence, and sincere friendliness shone through to everyone around her. She was a model of kindness and caring and we can all fall back on that example ourselves now, for help in dealing with her loss.
