- 4/ Do the increased contract prices reflect a perfect correlation to the changes in the project cost assumptions or is the developer absorbing some of the cost changes?
- 5/ Provide additional detail on the specific cost drivers for the EPC and Balance of Plant costs.
- 6/ Explain why the cost data in AL 3703-E, Confidential Appendix D at 19-21, does not correspond to the cost assumptions provided on July 9, 2009, in response to an Energy Division Staff data request. Specifically, explain why the "Old Assumptions" in the cost data table provided in AL 3703-E differ from the "New Assumptions" in the aforementioned response to staff's data request. A table reflecting this cost information was also included in Resolution E-4266 at 32.
