Subject: Congresswoman Speier Meeting Request

All:

Congresswoman Jackie Speier would like a meeting with us once we release our filing to the PUC on automatic/remote shut off valves. She indicated that she would like to have the meeting possibly the day of, or the day after, the release. She will also be inviting the Mayors of the cities in her district to attend. While we may not be able to accommodate the day of/day after, I would recommend that we proactively find a time as close to the filing date as possible and work from there.

Also, one of the other topics they would like to address at that meeting, in addition to the PUC filing, is our Pipeline 2020 program. They will likely send us questions in advance of the meeting regarding Pipeline 2020. I also expect them to raise questions about our work analyzing alternatives to replacing the ruptured pipe.

In terms of meeting participation, I assume we would want to make certain that we both provide some consistency in terms of those that have met with the Congresswoman previously, in addition to including representatives from Local Gov Rel and other subject matter experts that will be able to answer her questions. Steve Whelan, Gary Grelli and I have participated in previous meetings with the Congresswoman. Mary Ellen and Travis, if you could let me know who should attend from Local Government Relations, that would be great. Also, my thought was that we might also want to have relatively senior level participation from those that can provide responses regarding the Pipeline 2020 program, the PUC filing, and alternative routes.

I look forward to your thoughts and will share information as I receive it.
