There are three sets of data in question.

1) In Res. L-403 we were to complete our aerial and ground survey of the gas transmission system by today. On October 5 we asked for a delay until 10/22 which delay Director Clanon just granted in writing.

2) Between Director Clanon's initial letter to PG&E and Res L 403 there are requests for valve location information. There are some conflicts in what is being asked for between the two and when it is due. I spoke with Director Clanon last week about this and he said that if there are conflicts between the two the Commission approved Resolution should control and therefore we are going to provide the valve location information on 10/22, per the Resolution.

3) We were asked to provide the "top 100" list of pipeline segments for 2008 and 2007 but there was only some informal understanding about when that would be

due. Coupled with all of the other data we are producing this is a high priority but still a challenge to collect the data and put it in a form that is readily understandable. I spoke with Director Clanon about this mid last week and said we thought we could produce it by 10/22.

So the bottom line is that we expect to produce the data requested on 10/22.

There is a lot of accurate information people are interested in having and we are producing it as fast as possible.
