**Subject: Establish Gas Preliminary Statement CE, San Bruno
Independent Review Panel Memorandum Account**

Pacific Gas and Electric Company (PG&E) hereby submits this Advice Letter to establish Gas Preliminary Statement CE, the *San Bruno Independent Review Panel Memorandum Account (SBIRPMA)*.

Purpose

PG&E files this Advice Letter in compliance with Ordering Paragraph 3 of Resolution L-405, which authorizes PG&E to establish the SBIRPMA to record the costs that will be incurred by the Independent Review Panel.

Background

On September 23, 2010, the California Public Utilities Commission (Commission, CPUC) adopted Resolution L-403, establishing an Independent Review Panel tasked with conducting a comprehensive study and investigation of the September 9, 2010 explosion and fire along a PG&E natural gas transmission pipeline in San Bruno, California. The investigation by the Panel will include a technical assessment of events, their root cause, and recommendations for action by the Commission to best ensure such an incident is not repeated elsewhere. The Panel will also review the facts gathered and make recommendations to the Commission for the improvement of the safe management of PG&E's natural gas transmission lines.

On October 14, 2010, the Commission identified the members of the Independent Review Panel and adopted Resolution L-405, which declared that an emergency exists requiring immediate action by the Commission to hire expert consultants immediately to assist the Panel to investigate the safety of increasing the pressure of PG&E's pipeline to its normal operating pressure during the winter of 2010 through 2011, or whether other measures should be taken to ensure a sufficient supply of natural gas to PG&E customers on the San Francisco Peninsula and the City and County of San Francisco.

In Resolution L-405, the Commission ordered that PG&E pay for the costs of the Independent Review Panel and record such costs in a memorandum account. Resolution L-405 further stated that issues regarding the allocation of costs of the Panel between shareholders and customers shall be determined later.

Proposed Preliminary Statement

Pursuant to OP 3 of Resolution L-405, PG&E is requesting Commission authority to establish Gas Preliminary Statement CE, the SBIRPMA for gas (SBIRPMA-G), and record the costs of the Independent Review Panel.

CE. SAN BRUNO INDEPENDENT REVIEW PANEL MEMORANDUM ACCOUNT (SBIRPMA) (N)

1. **PURPOSE:** The purpose of the SBIRPMA is to record the costs of an Independent Review Panel (Panel) of experts established by the Commission under Resolution L-403, adopted on September 23, 2010. The Independent Review Panel was established for the purposes of conducting a comprehensive study and investigation of the September 9, 2010 explosion and fire along a PG&E natural gas transmission pipeline in San Bruno, California. The Panel's investigation shall include a technical assessment of the events and their root causes, and recommendations for action by the Commission to best ensure such an accident is not repeated elsewhere. The Panel's recommendations may include changes to design, construction, operation, maintenance, and replacement of natural gas facilities, management practices at PG&E in the areas of pipeline integrity and public safety, regulatory changes by the Commission itself, statutory changes to be recommended by the Commission, and other recommendations deemed appropriate by the Panel. The Panel will also review the facts gathered and make recommendations to the Commission for the improvement of the safe management of PG&E's natural gas transmission lines. The allocation of costs of the Panel between PG&E shareholders and customers shall be determined by the Commission in a future proceeding.
2. **APPLICABILITY:** The SBIRPMA shall apply to all gas customers except for those specifically excluded by the Commission.
3. **REVISION DATE:** Disposition of the balance in the account shall be determined by the Commission in a future proceeding.
4. **RATES:** The SBIRPMA does not have a separate rate component.
5. **ACCOUNTING PROCEDURE:**
 PG&E shall make entries at the end of each month as follows:
 - a) A debit entry equal to any cost of the Independent Review Panel of experts for the purposes of conducting a comprehensive study and investigation of the September 9, 2010 explosion and fire along a PG&E natural gas transmission pipeline in San Bruno, California.
 - b) A debit or credit entry equal to any other amounts authorized by the Commission to be recorded in this account.
 - c) A debit or credit entry equal to any amount authorized by the Commission to transfer amounts to other regulatory accounts, as appropriate, for rate recovery.
 - d) A debit or credit entry equal to the interest on the average balance in the account at the beginning of the month and the balance after the above entry, at a rate equal to one-twelfth of the rate on three-month Commercial Paper for the previous month, as reported in the Federal Reserve Statistical Release, H.15, or its successor.
