San Bruno Blast Victims Get Buyout Offer from PG&E

SAN BRUNO -- Pacific Gas and Electric Co. is offering to buy out San Bruno residents whose homes were destroyed or badly damaged in last month's deadly natural gas pipeline blast, according to documents obtained by The Chronicle.

Those who sell fast - within six months - stand to collect a hefty bonus: \$50,000.

The offer comes as many victims worry about their land value and the difficulty of rebuilding, and as PG&E seeks to restore public trust after the Sept. 9 blast that killed eight people, destroyed 37 homes and damaged 18 more.

San Bruno Disaster Could Enrich PG&E Shareholders

Pacific Gas & Electric Co. shareholders could profit from last month's San Bruno explosion because the fatal accident will lead to increased investments in its natural gas infrastructure, Bloomberg reported.

Up to \$50 billion is expected to be spent modernizing networks of aging pipelines that sprawl across the nation in the wake of the Sept 9 disaster, it was reported.

"PG&E's plans to replace older pipes were 'constrained' by regulators, who capped spending they saw as unnecessarily driving up customer bills," Bloomberg reported, citing financial analysts. "Investment may benefit utilities such as PG&E, which can pass on the costs to customers through rate increases that include an allowance for profit."

Remembering Jimmy

Early in the afternoon Saturday, more than 20 longtime friends of James "Jimmy" Franco gathered at the mouth of Linda Mar Creek on Pacifica State Beach to give him a surfer's farewell.

Jimmy died on Sept. 27 at the UCSF Medical Center after he did not awake from a drug-induced coma doctors had put him before treating the severe burns he sustained during the San Bruno fire. He was renting a room in a house located 250 feet from where the PG&E gas pipeline exploded. Jimmy turned 58 years old while he was comatose.

After market close on 10/15/10, Pacific Gas & Electric Co. (NYSE: PCG) announced that it had reached a full settlement in the pending Electric & Gas General Rate Case., Citigroup reports. The agreement includes a total of 17 parties out of 19, including the

California Division of Ratepayer Advocates and The Utility Reform Network.

"The agreement contains a three-year revenue increase, adequate levels of cost recovery and cap-ex, reduces to some extent regulatory concerns in the wake of the San Bruno explosion," Citigroup writes. "The agreement should allow PG&E to meet our EPS estimates for both '11 & '12."

PG&E Drops Lindaro Street from Pipeline List

I have reported on our interactions with PG&E on pipeline safety in the last 2 editions of Snapshot, and have good news to relate this week. We had asked PG&E why the 1,900-foot line on Lindaro Street between the Corporate Center and Woodland Avenue had been identified as #22 on their "Top 100 List" and asked that its evaluation be expedited. PG&E did expedite the inspection and responded that the pipe thickness had been in question, and this placed the pipe on the list. PG&E pipeline engineers have now confirmed that the wall thickness meets specifications, shows no corrosion and is not in need of repairs.
