Hello Olivia:

In order to expedite PG&E Advice Letter (AL) 3155-G/3739-E (San Bruno Bill Relief), the Energy Division of the California Public Utilities Commission is reducing the protest and reply period, pursuant to Section 1.3 of General Order 96-B. The Director of the CPUC's Energy Division has authorized the reduction of the protest and reply period in order to facilitate the disposition of PG&E's AL request to provide immediate bill relief to customers affected by the gas pipeline explosion occurring at San Bruno.

Protests to the AL are due no later than October 11, 2010. PG&E's reply to any protests are due no later than October 13, 2010.

PG&E shall immediately notify the AL 3155-G/3739-E service list about these changes.
