CCA/EE Workshop Participants:

Here is an update on where we are in the process of developing the CCA/EE Workshop Report.

- 1, Attached is typed up list of participants from the workshop. Please send any corrections to me.
2. Barbara George plans to circulate the draft workshop summary on Tuesday, 10/12.
3. PG&E and CCSF have been checking in by phone this week and plan to exchange drafts early next week and determine if there is enough common ground to ask for an extension until 10/22 to continue discussions; or whether it will be better to submit the report on 10/15 with parties having the opportunity to submit reply comments on 10/22.
4. Commissioner Grueneich's advisor Matthew Tisdale and PG&E spoke today to discuss the scope and schedule of the report. We explained where we were in the process (see 3 above) and will contact him early next week to confirm the schedule for submitting the

report and whether to request an opportunity for parties to reply. He seems amenable to issuing a ruling as needed to extend the deadline.

5. We plan to circulate the draft report or a further update to the workshop participants by mid-week (10/13).
