Yesterday PG&E
continued its listening tour in Marina City. And the City asked the CPUC
to also give a presentation, so I went to listen and present. It seems
that we have a following in this listening tour - the ladies of EMF Safety
Network joined us at the city council meeting as public speakers.

The mayor is up for
re-election and one of the council members sitting beside him is his
opponent. For the first hour or so we heard a very acrimonious
back-n-forth discussion about who is more qualified followed by public speakers
supporting one or the other. This was followed by a group wanting to build
a dog training development center, but the horse riders were upset because the
new development center would run through existing horse trail. One of the
horse people also voiced his concern over RF emissions on our animals including
the horses and the dogs - he presented evidence that one horse had major health
issues, then the doctor said to turn off the wireless "microwaves" near the
horse, and as soon as he did that the horse was up and running and healthy as

ever.

The smart meter

presentation started off with me giving a background on how we got to the 2006 decision and why smart meter and smart grid. I got the brunt of the hissing and heckling because I went first (I will not be going first again). I was asked to define smart grid and why it is needed, so I used the room as an example with 8 microphones plugged into the wall, 5 cameras plugged into the wall, 3 computers plugged into the wall, projector plugged in and lights every where...
