TO ALL PARTIES IN PG&E'S 2011 GT&S Rate Case (A.09-09-013):

Attached is the final witness list for the hearings in PG&E's 2011 GT&S Rate Case, scheduled to begin on October 25, 2010, based upon the time estimates for cross and witness schedules I have received. Given the attached schedule, PG&E proposes that the order of witnesses be as follows:

October 25, 2010

Johannes Van Lierop (90 minutes)  
Steve Watson (175 minutes)  
(\*if time permits) Tom Beach (30 minutes)

October 26, 2010

Krishna Yadav/Dennis Henderson (60 minutes)  
Tom Beach (assuming he did not testify on 10/25) (30 minutes)  
Roger Graham (105 minutes)  
Ray Blatter (60 minutes)

October 27, 2010 may be needed only if Roger Graham and/or Ray Blatter have not finished testifying. Because there are some witnesses that will not be cross-examined, please confirm your agreement that anyone who isn't being crossed need not appear, and that their testimony will be admitted into the record. Similarly, attached is a list of exhibits that PG&E intends to move into evidence on October 25. Please confirm your agreement that these documents may be received into evidence, without a sponsoring witness present to authenticate the exhibit.

Finally, PG&E proposes that the parties agree to share any documents that they intend to use on cross-examination with other parties 24 hours before the cross-examination during which they intend to use the document. Please confirm your agreement. Thanks.
