Long road home: San Bruno survivors cope with trauma of deadly blast

Amarjeet Kaur ran without shoes from her home Sept. 9 as the flames from a natural gas explosion shot in through an open back window. She didn't know if her 7-month-old son was alive.

Nearly a month after the blast, she cannot sleep. And when she does, she has nightmares about the fire, which killed eight people and destroyed 37 homes. The clanking of trains at a nearby rail yard makes her jump.

New lawsuit filed against PG&E over San Bruno blast By Joshua Melvin October 5, 2010

The natural gas pipeline explosion that killed eight people and destroyed 37 homes in San Bruno was Pacific Gas and Electric's fault, a class-action lawsuit claims.

San Bruno resident Daniele DiTrapani filed the suit in San Mateo County Superior Court and is seeking unspecified damages for himself and others like him.

Echoing a suit filed Sept. 17 by another San Bruno resident, this complaint seeks to force PG&E to turn over control of the \$100 million victims fund to an independent body.

San Bruno begins the slow work of rebuilding By Jason Pun and Khiry Crawford October 4, 2010

Three weeks after the Sept. 9 gas line explosion, San Bruno begins to settle down while new information is released and more fatalities are announced.

Amidst the 66 injuries, 34 houses destroyed, 15 acres razed, and 7 reported deaths, another San Bruno Resident died Monday, Sept. 27. James Emil Franco died after 16 days, hospitalized after the blast. Franco's death brings the total fatalities to eight. His body was scheduled for autopsy Sept 28, but the San Mateo Coroner's Office had no comments on Franco's cause of death beforehand.

A new bill, the Strengthening Pipelines Safety and Enforcement Act, will establish redefinitions for gas line regulation. These include stating that 200 safety inspectors are responsible for 2,000 miles of pipeline, electronic shut-off valves, "smart pig" robots for pipeline inspection, the prohibiting of keeping natural gasses at high pressures without inspection, and prioritizing old pipes closest to seismic areas.

PG&E released a "top 100" list of pipelines due for evaluation and maintenance Sept. 20. The San Bruno pipeline wasn't included within this list. PG&E defends the list- the list is not a high

risk assessment, but a list intended for planning future planning, said PG&E spokesperson Katie Roman.

That 10-inch line was installed in 1945 and the utility is conducting engineering studies on it but has assured officials there are no problems with it.

The natural gas explosion in San Bruno, Calif., has investigators focusing on pipelines, but critics say the electrical system gets short shrift. Pacific Gas & Electric has investigators <a href="mailto:checking">checking</a> the age and condition of natural gas pipelines, their operations and maintenance records, but public officials and customers say they suffer too many electrical blackouts at the hands of PG&E, the San Francisco Chronicle reported Friday.

"They get <u>money</u> for maintenance, and then they find other priorities to shift the <u>money</u> to, and the maintenance doesn't get done," said Bob Finkelstein, legal <u>director</u> for The Utility Reform Network, a consumer watchdog group.
