PG&E agrees to remove gas pipeline from

Pacific Gas and Electric Co. said Friday that it intends to move the natural gas pipeline that exploded last month out of the San Bruno neighborhood where the disaster occurred, killing eight people.

"This community has been through a terrible tragedy," PG&E spokeswoman Katie Romans said. "We absolutely understand that no one wants the pipeline to be rebuilt in the neighborhood. We, too, do not want to rebuild the line in that same location."

PG&E says blown gas line won't be rebuilt,  
officials say

PG&E has committed to not reconnecting the natural gas pipeline that exploded in the city's Glenview neighborhood last month, state and local officials said Friday, though local residents said they want to hear the same message from the utility itself.

State Sen. Leland Yee and Mayor Jim Ruane said at a City Hall news conference this afternoon that utility officials committed in a private meeting that they would not reconnect Line 132 in its current location.
