In accordance with Rule 8.3 of the Commission's Rules of Practice and Procedure, San Diego Gas and Electric Company (SDG&E), Southern California Gas Company (SoCalGas), Quality Conservation Services, Reliable Energy, and Disability Rights Advocates hereby give notice of the following ex parte communications in the above proceeding.

On Thursday, October 7th, 2010, Pedro Villegas, Manager of Regulatory Relations for SoCalGas and SDG&E, Rick Hobbs, Director of Customer Assistance for SoCalGas and

SDG&E, Kathy Wickware, Energy Program Advisor for SoCalGas and SDG&E, and Joy Yamagata, Regulatory Case Manager for SDG&E and SoCalGas, held two separate meetings on the Proposed Decision (PD) in this proceeding. Also in attendance were Michael Lizarraga, President and CEO of TELACU; Richard Villaseñor, Board Member of ACCES; Jim Hodges on behalf of TELACU, Maravilla Foundation and ACCES; Allen Rago of Quality Conservation Services; Ron Garcia of Reliable Energy; and (by telephone) Melissa Kasnitz of Disability Rights Advocates. Mr. Villegas initiated both meetings. Communication was oral and written (Attachment A).

The first meeting with Carol Brown and Karl Meeusen, advisors to Commission

President Michael Peevey, and with Sepideh Khosrowjah and Jason Reiger, advisors to

Commissioner Nancy Ryan, was held at 1:00 p.m. at the San Francisco offices of the

Commission and lasted approximately one hour. The second meeting with Kelly Hymes, advisor to Commissioner Dian Grueneich, was held at 3:30 p.m. and lasted approximately 40 minutes.

Mr. Villegas stated that the relief requested in the petitioners Petition for Modification (PFM) requires no additional funding from the Commission and would provide SoCalGas and SDG&E with needed tools to meet the Commission's ambitious 2009-2010 low-income energy efficiency (LIEE) goals for number of homes to receive Natural Gas Appliance Testing and LIEE measures, and for LIEE penetration among self-identified disabled customers. Mr. Hobbs, Ms. Wickware, and Mr. Villegas described the relief requested in the PFM per the attached presentation. Mr. Hobbs stated that SoCalGas currently is forced to turn away LIEE customers under specific conditions of the LIEE decision, and that the requested relief would remedy those conditions to allow more customers to participate in LIEE. Mr. Villegas stated that the PFM is

unopposed by the parties to the LIEE proceeding, and that the current PD fails to support the LIEE goals of the Commission by wholesale denying the requested relief in the PFM.

Subsequent to the meetings, a document was submitted electronically to Kelly Hymes by Billy Blattner, Manager of Regulatory Relations for SoCalGas and SDG&E, on October 12, 2010 providing examples of CPUC direction to utilities, in various proceedings, addressing the establishment of memorandum accounts for the purposes of tracking costs (Attachment B).
