Hoboken Opposes Gas Pipeline Plan, Citing Danger to PATH System

Hoboken has added its voice to the chorus opposed to a proposed natural gas pipeline that would run through Jersey City to Manhattan.

HOBOKEN AND BEYOND – Although the natural gas pipeline proposed by Texas company Spectra Energy to run through Bayonne and Jersey City would skirt the southern border of the Mile Square City, opposition to the plan is growing here, according to a NJ.com report.

In the event of a pipeline disaster, like the one that killed eight people in San Bruno, Calif. last month, Zimmer argued that Hoboken would not be able to sustain the inevitable shutdown of the PATH system under which the line would run.

## California Explosion Sparks Questions in Missouri

COLUMBIA - A recent natural gas pipeline explosion in a San Francisco suburb that killed eight and left dozens of homes damaged gives cause to look into pipeline safety in Missouri. But, finding information about where pipelines are and how they are doing is harder than you would imagine.

It is hard to pay attention to all the markers on the ground. In fact, Public Service Commission Chairman, Robert Clayton said there is so much underground, from water lines to telephone cables- it is hard to mark it all. "Gas is what we call a critical resource" said Clayton. "People need it to stay warm." Clayton said natural gas is so critical he can't reveal where bigger and high pressure natural gas pipelines are located and the status of the pipe for security reasons.

### Gas Company Allays Concerns about Chance of Explosion

ABSECON – It couldn't happen here.

That's what the South Jersey Gas Co. said, and that was the happy message that City Councilman Jim Vizthum brought to the community Thursday, Oct. 7.

"About a month ago an explosion in California set off a fire that swept through a neighborhood, destroying at least 38 homes and damaging dozens more," Vizthum said at council's first meeting in October. "By most accounts, the authorities are blaming a 30-inch gas line that was leaking and eventually caused the explosion."

After doing a little research on his own, Vizthum said he asked City Administrator Terry Dolan to look into how safe Absecon would be from a similar accident.
