Team,

Rachel Carr, who is the Democratic Counsel of the House Subcommittee with jurisdiction over pipeline safety, will be touring the San Bruno site with CPUC staff this Wednesday, Oct. 20. She will be joined by her colleague, Joe Connelly who is more technical in nature. The exact time nor CPUC staff person has been confirmed. In addition to the tour, Rachel would like to meet with PG&E staff to discuss a variety of topics, including the status of Line 132, how the gas is flowing, what repairs are expected, what our interactions with the CPUC were prior to the accident, info on the claims process.

For now, no hearing is planned, the staff are doing the trip on background. This accident introduces a new scenario for them given the intrastate pipeline and state PUC oversight.

Rachel seemed fine with PG&E staff being part of the SB tour or available for a separate meeting on

Thursday AM.

It may make most sense to have folks like Mary Ellen and Bill join Rachel and Joe for the tour and address most of their questions at that time.

Please let me know your thoughts and availability. I'll provide more specifics on the tour as I get them. We should plan for it to be midday PDT Wednesday.
