PLEASE DELETE THIS PHRASE (last draft I got from CCAs deleted this phrase but it's still in the report:
and be well-integrated with statewide and other broad-reaching existing programs.

THOUGHT THIS WAS ALSO DELETED: but as per usual CPUC process, could provide comments.
