PG&E refiled the workshop report at the request of the docket office today to correct a procedural issue. Removing text relating to the term administrator would constitute a substantive change that could require additional substantive revisions to the proposals.

It is my understanding that WEM signed onto the final report last week after being informed that the report contained the language quoted in your email below. In any event, the language makes clear that it is not meant to be restrictive. At this point, I think it is appropriate to voice any substantive concerns or clarifications in the upcoming comments. If you would like to remove WEM's name from the report, PG&E will not oppose your motion.
