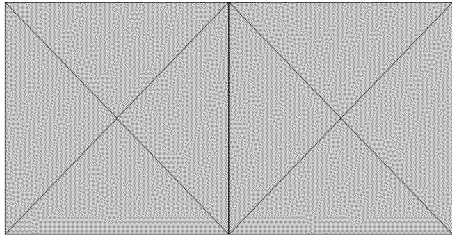

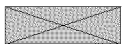

We have a deal with our shipper to charge \$40 per case to ship anywhere in the lower 48! And of course, if you are located outside California, the cost minus the sales tax is \$192 per case. (or \$16 per bottle).

You can always call Diane to take your order directly (707) 226-2634. If you want to pay by check multiply by the number of cases plus \$40 per case for shipping and enclose your check. Call Diane, if you have any questions or concerns about anything!

Please think of our wine as a special holiday gift to family, as well as valued friends and clients, and of course for the years ahead in your own cellars. Diane is now selling out at the rate of 25-50 cases per month so this remaining wine will not last long!!
