Subject: Direct Access- Uniform Resource Requirements Working Group- DRAFT Memo

As discussed at the October 18 Direct Access Working Group meeting, attached for review and comment is the draft memo to Energy Division on the 3<sup>rd</sup> Working Group (Uniform Resource Requirements). The memo incorporates all changes and suggestions from various parties over the last two months as well as the comments and suggestions made at Monday's meeting, with most of the changes occurring on the QF/CHP item. Energy Division requested an update by November 15<sup>th</sup> for each of the three working groups, this memo covers working group 3 only.

In summary, the document explains that parties agree that all issues associated with ensuring uniform resource compliance between IOUs and ESPs and cost allocation are all being addressed, have pending decisions, or are within the scope of other Commission proceedings and do not need to be addressed within the context of the DA OIR. The document gives a brief description of each item and where it has/will be addressed and a brief description of non-consensus issues.

Please review and provide any REDLINED comments by **COB Monday November 1** (while we originally discussed the due date of October 29, I'm adding on an extra business day since this draft went out a day later). As discussed at Monday's meeting, if there are no major issues, this document will be filed on the service list and sent to Energy Division in advance of the November 15<sup>th</sup> deadline. If issues do arise from the redline comments, I will schedule a conference call to discuss.
