Hi Raj,

I am writing to give you a status update on comments to the Draft Resolution issued on 11/2. Per the Draft Resolution and the CPUC's Rules of Practice and Procedure, comments are due to be submitted on or before November 22, 2010. We should have no problem meeting that deadline and as we discussed on the phone last week, I will continue to coordinate with the other energy utilities to submit comments as soon as possible.

I am aware that you will be taking vacation beginning on Wednesday. However, despite our best efforts, it does not appear that we will not be able to submit comments to you by tomorrow morning as you requested. We are still working to prepare the comments and I will need to run them through our management review process before we can submit them. Even on an expedited basis that process will likely take a couple days minimum. I suspect the other utilities will need to do the same.

Originally, when we spoke on the phone about the timing for submission of comments you informed me that you would arrange for a delegate to review any comments that were submitted after your vacation began. When we spoke last Friday, I was disappointed to hear that there is a possibility no one will be assigned to review comments in your absence even if submitted within the time designated by the Draft Resolution. Please let me know if that is, in fact, the case. If so, it might be prudent to request that the Commission vote this resolution out at the December 16 meeting, as opposed to the December 2 meeting, so that the energy utilities' timely comments can be reviewed and incorporated as appropriate.

I will continue to coordinate with the other energy utilities and work to prepare and submit our comments to the CPUC as soon as possible. Please feel free to contact me if you would like to discuss further. Thanks and have a great vacation.
