Existing policies and procedures are in effect until the Commission changes those policies. Pending the outcome of the Commission's actions on the PFM, the process will continue to be consistent with all Commission directions on this matter.

Commission Grueneich addressed this at the prehearing conference. The below is lifted from the transcript.

21 The other thing that I did want to

22 say quite clearly was that until the

23 Commission acts, the decision that we issued

24 with regard to the 2010-2012 portfolios as

25 well as the strategic plan and everything

26 else we have in energy efficiency is in full

27 force and effect. And I certainly fully

28 expect that with regard to our utilities,

1 with regard to the Energy Division and with

2 regard to anyone else who is affected by it,

3 that we are complying with that decision.

4 I'm not saying there's anything in

5 particular but I wanted to make sure that we

6 are all clear about what is the legal impact

7 right now. That this is an area where we may

8 have some differences, but we're sitting in

9 this room today because we care about energy

10 efficiency and we need to make sure that we

11 are all moving ahead with the programs as

12 best as we can, even while we're still trying

13 to resolve what obviously are some very

14 critical issues.
