- 3. Provide a list of all legal cases relating to William Devereaux's monitoring of online smart meter discussion groups.
- 4. Describe Mr. Devereaux's role with PG&E's SmartMeter program.
- 5. Provide organizational chart for Mr. Devereaux's SmartMeter Group including the reporting structure for Mr. Devereaux.



- 6. Identify any work groups within PG&E, Mr. Devereaux or his team regularly worked with, including the nature of the work group and associated organizational chart.
- 7. Did Mr. Devereaux review SmartMeter or EMF complaints received by PG&E?
- 8. Provide copies of all email, or phone correspondence, meeting notes, or internal communications related to PG&E's investigation into William Devereaux's monitoring of online smart meter discussion groups.
- 9. Describe the action(s) PG&E has taken or plans to take as a result of Mr. Devereaux's monitoring of online smart meter discussion groups.

- 16. When did PG&E first learn that Mr. Devereaux was monitoring online smart meter discussion groups?
- 17. Provide a listing of all meetings and appearances made by Mr. Devereaux at the CPUC, relating to the smart meter program, since July 2009. Include copies of all documents developed as result of those meetings and appearances, attendee names, presentations, notes or meeting minutes,
- 18. Provide copies of all communications Mr. Devereaux provided to the CPUC's Energy Division, Commission Offices, or the Executive Director.
- 19. Provide a list of Mr. Devereaux's public appearances relating to the smart meter program, since July 2009; include date, and location of appearance.
- 20. Provide all reports, memos, white-papers, and briefs Mr. Devereaux authored, co-authored, contributed to, or oversaw relating to EMF.
- 21. What is Mr. Devereaux's involvement in any past, current or pending litigation relating to the smart meter program?
