Slide 1: Change GAV to GA 5-- DONE

Slide 2: : Took all editorial except

- Bullet 1-- we need to discuss inclusion of rates language. I have a compromise suggestion bracketed but need to make sure my team is comfortable.
- Last bullet -- did not characterize SoCal/SDG&E as G-XF issues only since they do have the storage issue.

Slide 3. :Took all your editorial except

- Last bullet -- While not part of the Settlement, PG&E needs to be clear that Gas Accord Settlement does not fully address future directives CPUC may have.

Slide 4: Took all your editorial except

- Bullet 1--once again we need to talk about the rates language. I have similar compromise language but know my team has issues

Slide 5: Took your editorial. However I agree we need to talk about presentation of this material. Any work you have done would be appreciated. [Redacted] and [Redacted] have been tied up and they are my source for good tables and numbers here, but the idea is to show average rate increases in Non-Core for services and in average core bundled rate. With respect to the chart, if you have one that effectively shows Settled vs. Filed RRQ which is the basis for the \$95 MM I would love to go with it. So, let's talk tomorrow.
