I believe you are correct that SDG&E and SoCalGas do not have confidential information submitted in our current workpapers or early ED opinion requests.

However, as a cautionary recommendation, not knowing the duration of allowing DRA and TURN access to Basecamp and the full content of Basecamp now and in the future—Should DRA be given access under the “General Order 66-C and PU Code Section 583” and TURN be made to sign an NDA with each of the IOUs to be on the conservative side. This is particularly important given the short timeframe we have to respond to the request.
