Michael, we are going to be having a meeting tomorrow at 10:00 am at my offices at 101 California Street to discuss further the PRV enhancement projects. I expect that Raj, along with several representatives from the water utilities, will be there. It would be great if you can attend as a representative from the electric utilities.

Raj and I did meet this past Thursday (along with Tom Victorine from San Jose Water Company). We discussed several points that the Commission desires in connection with these projects, including the following:

1. The roll out of these projects should proceed quickly and smoothly, with maximum cooperation between the water and electric utilities.
2. You, for the electric utilities, and I, for the water utilities, should act as the single points of contact with Raj, for the Water Division, on legal, regulatory and contractual/commercial matters.
3. The water utilities will retain a single engineering consultant to oversee the roll out of the projects; this consultant will largely take direction from Raj on behalf of the Water Division.
4. The water utilities will retain a single EMV consultant to oversee the roll out of the projects; this consultant will largely take direction from Raj on behalf of the Water Division.
5. The engineering and EMV consultants will have bi-weekly meetings with Raj to provide updates on the progress of the program. You and I will be included when necessary.
6. The Commission would like these projects to move forward as quickly as possible, as the purpose is to find out if it makes sense to roll out these projects on a broader scale for the benefit of customers.

Raj, anything to add?

Michael, let me know if you have any questions or comments and please coordinate

with the other electric utilities. I hope to see you tomorrow. Joe
