Tonight PG&E fulfilled its commitment to fully engage with its customers in Fairfax by holding its third and final public forum on the subject of SmartMeters

As anticipated and experienced in previous meetings, the attendees were openly hostile. I want to extend specific thanks and acknowledgement to Jess Brown and Jana Corey who listened and responded empathetically to our customers' concerns in a very difficult environment.

The Town of Fairfax hosted PG&E at the second community meeting held in response to the myriad of questions submitted by Town residents at the "Listening Session" held on September 16th. The first responsive community meeting addressed the issues of RF, health, and the SmartMeter program in general. This evening's meeting addressed privacy, security, and billing accuracy. The Mayor of Fairfax opened the meeting by introducing Greg Kiraly, VP of SmartMeter Operations. Greg took the opportunity to express PG&E's commitment to cooperation with the Town and willingness to be responsive to the concerns of the community in an open forum. Greg also touched upon the media reports surrounding the circumstances of Bill Devereaux's departure and P&GE's continued commitment to the core values of our company. Further, he stated that PG&E is currently in the very early stages of potentially developing other options to SmartMeter but did not elaborate on details. Lastly, Greg introduced PG&E's panel: Jess Brown, Dir. of ES&S, Jana Corey, Dir. Policy Planning, and Marzia Zafar, CPUC Rep. Jess explained billing accuracy and Jana answered questions regarding privacy and security. Michael Hertz was also called upon to answer technical RF questions. Fervent and emotional public commentary ensued for nearly two hours with almost 25 speakers. Finally, the Council, one by one, gave remarks including the request for a fourth meeting (which was not committed to at this time) and also expressed hope the PG&E would indeed develop a hard-wire option for the Town of Fairfax.
