Marzia, In addition to the Commissioners hearing tomorrow about RF, I would add one thing. It is likely that these speakers at the meeting tomorrow will also pressure the Commission to come up with options to our SmartMeters, or encourage the Commission to pressure us to come up with alternatives.

Just so you know our position, as you may recall, last night Greg stated that we are currently evaluating options that we hope will alleviate the concerns of our customers and still enable us to upgrade all of our meters to SmartMeters. He also made the point that we are in the preliminary stage of review, including weighing the cost of any potential options. He also promised to make this information available in the coming months as we develop it.

Of course, we all want to address our customers' concerns while ensuring them the benefits that the SmartMeter and the Smart Grid offer.

Here's my report from last night's meeting. I know I'm pretty brutal with my opinions of how PG&E conducts itself at these meetings, but I thought last night you guys did a great job especially the gentlemen sitting next to Jana.

Hello,

Last night I attended my third town council meeting in the great Town of Fairfax. However, I will not be attending more events in the great Town of Fairfax. They have lost proper perspective and are demonstrating mob mentality in its finest form.

The mayor was very vocal against smart meters so when he held up his iPod touch I asked whether that was a "wireless iPod touch" emitting constant RF in his hip pocket... There was a retired computer programmer who was afraid that the smart meter was too close to her knee and she recently recovered from cancer in that knee. Overall PG&E did a very good job of listening and sympathizing and giving very good/common sense info, but the crowd is too far gone.

So, largely same people, but the tone a little more vitriolic than in the past; less stories and more anger. There were about 40-50 people in attendance. The session started at 7:30 and lasted till about 11pm. The mayor and the vice mayor along with the other 3 members all pretty much have the same view which is that PG&E is infringing in their civil liberties by trespassing in their house to install a smart meter. They also agree with the crowd that RF is a huge issue and this is yet another piece of equipment that will cause them harm.

Interestingly, they are looking forward to the CCST report and urged the PUC as well as PG&E to wait for the report to pass public scrutiny before making anymore decisions. This is interesting, because the last time I asked them whether they would believe in the CCST report, and they all in unison said "NO", but this time they were very positive about CCST and also mentioned that they've been in constant communication with CCST who told them that the report will be issued in the next 2-3 months.

*Potential caution* - the public speakers warned that they will begin to practice public disobedience if smart meter installations began in their respective towns (i.e. Fairfax, Pt Reyes area, and west Marin). They also all encouraged each other to attend tomorrow's Commission meeting and voice their discontent about the ALJ PD dismissing EMF Safety Network's application.

It should be noted that we're still talking about 200-500 people who granted are very vocal and committed to their cause, but they're not representatives of their larger communities.
