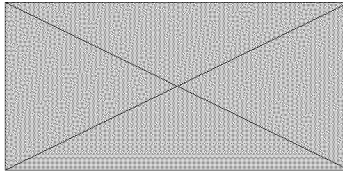
I wish to add to the beginning of the agenda the following items:
