At the request of Energy Division, today Pacific Gas and Electric Company (PG&E) re-served Advice 3170-G/3763-E to the parties of record in R.10-05-004. Advice 3170-G-A/3763-E-A was filed today, superseding 3170-G/3763-E, which contains supplemental information regarding PG&E's CSI contract administration procedures. As a result, the protest period for the supplemental advice filing will re-open and that protest period will end January 6, 2011. CCSF and CARE do not need to re-file the protests they filed on December 13, 2010 but may choose to do so or to amend/supplement their protests in response to PG&E's supplemental information.

Pursuant to Rule 7.4.3 of General Order 96B, PG&E will respond to all protests, including the protests filed on December 13, 2010, no later than January 13, 2011, five business days after the end of the new protest period.
