Hi - It is a notice requirement. 49 CFR Part 193 deals with LNG facilities. Part 193.2019 (a) provides that the Part 193 requirements don't have to be met for mobile or temporary LNG used during "service maintenance" or "during gas systems repair or alteration". Part 193.2019 (b) provides that the state agency responsible for pipeline safety must be notified two weeks in advance of the use of any mobile or temporary LNG facilities. The information to be provided includes location and site details, procedures for leakage containment and control, fire prevention and site control information. The provides that in the event an emergency, if the two weeks notice can't be met, as much notice as possible shall be provided.

Since this is a type of emergency we should be willing to waive the notice requirement.

LNG - Below are some dates that Austin has provided to get LNG available asap. Austin needs to configure the equipment in new ways for the types of applications and therefore needs to perform testing and training. He currently has training and testing scheduled in Yuba City for the week of December 13. This training will reduce risk and doubt in the capability and ability of these systems used in this type of configuration. The testing is scheduled for that week due to the two week lead time notification to the PUC.

Ideally, Austin would like to test and train on the following schedule provided the PUC waives the two week notification requirement:

He does not anticipate an issue with the SFFD and will continue the discussion with them regarding our return to the SFGLC and the Presidio injection location.

Where we could use some high level help is to get the CPUC to work with us to waive the 2 week notification requirement so Austin can complete his testing and training so that LNG can be available asap. Overall LNG looks promising and if we can get all of the above in place we do not expect the need for core curtailments.
