Pursuant to CPUC Decision 06-10-050, the Executive Director is authorized to hire contractors for the purpose of advancing RPS goals, with cost recovery from ratepayers through the large IOUs. PG&E, SCE, and SDG&E are responsible for the payment of these costs on a proportional basis in relation to the annual retail sales used for the RPS Program, as reported in each March 1 RPS compliance report. To protect confidential data, Energy Division used 2009 retail sales reported in each IOU's March 1, 2010 report to determine the allocation of costs.

The IOUs are authorized to record these RPS third party technical support costs into the Renewables Portfolio Standard Costs Memorandum Account (RPSCMA) until December 31, 2010. These costs may be recorded when paid, for later recovery via generation rates.

CIEE / UC Office of the President submitted Invoice 57040-012B for work performed since March 15, 2010. The invoice reflects labor and other expenditures incurred by CIEE / UC Office of the President and its consultants. The total amount of the invoice is \$171,395.

The Commission's Energy Division staff has reviewed and verified the expenditures and found them correct and properly supported with appropriate documentation. Below is the allocation of CIEE / UC Office of the President's expenditures to the utility companies.
