Here are the items I have for tomorrow's meeting:

1. Announcement of new ED program manager on LIEE, EM+V, and DR - Pete Skala (may or may not be able to attend, depending on his schedule commitments)
2. Regular ED-IOU SW program check-in meetings - Review objectives, roles / responsibilities, and feedback on how these are going so far
3. Data requests - Criteria, process, and ED feedback on quality control
4. Revised PIPs - IOUs report back on timing and process, after having conferred per action item from last meeting
6. Kick-off workshop (1/14 or 1/18) pursuant to D.10-10-033, and current thinking on subsequent workshop(s) to address related issues raised in 11/17 ACR on portfolio planning timeframe - FYI

Also please note, I spoke to Zeny about her participation in this meeting. Since she (and Athena?) will be at the all-day meeting to discuss the 2010-2012 EM+V plan, she has asked to be excused from participating in this meeting. The items being discussed at that meeting are the most relevant one for her to discuss at this time. That may be a topic for the next meeting, since Zeny would need to participate in that discussion.
