This notice announces that Pacific Gas and Electric Company (PG&E) is hosting a stakeholder meeting discussing reform to PG&E's Wholesale Distribution Tariff regarding the Small and Large Generator Interconnection Procedures. The California ISO hosted a similar reform effort and is approaching the end of their process, which applies to interconnection procedures on the transmission system. PG&E, who manages interconnection procedures on the distribution system, is now launching its reform process for generation interconnections under the Wholesale Distribution Tariff. PG&E's goal is to implement a new FERC approved tariff by Spring 2011.

PG&E values the input from our customers and is conducting a stakeholder meeting in San Ramon, CA, on December 13, 2011, from 1pm to 4pm to outline the principles underlying the reform and to receive input and feedback from interested parties. More specific details and meeting materials will be made available in early December.
