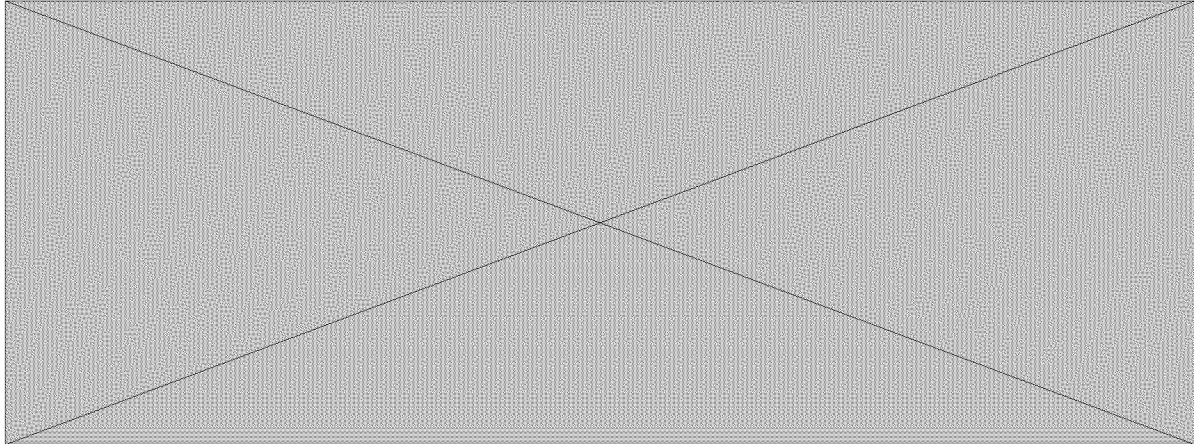

Charles –

Thank you for providing the response to question 1. As you may have seen, SCE provided a response to question 5, showing the relative difference associated with excluding renewables from the 2011 indifference rate calculation for the various vintages. SCE's response is shown as follows:

The table included below shows the reduction and percentage reduction to estimated indifference rates for all vintages in 2011.



PG&E did not provide a response to question 5, claiming concerns about confidentiality. I still don't see how the requested information could be confidential, particularly since SCE has now twice provided this same information. I understand how, in one year (if there is only one additional renewables contract and the MWhs associated with that contract were otherwise known), there could be a remote possibility that the price for that particular contract could be reverse engineered. But this scenario seems highly unlikely. Is this the concern PG&E has? If so, the concern would only be for that particular year, and all other years' information could be provided, since there would be multiple contracts to mask any prices, right? At a bare minimum, PG&E could provide 2011 information, since that year would have multiple contracts and no reference to other vintages, right?

I ask that PG&E reconsider its claim of confidentiality and provide such information, in the format used by SCE, that it possibly can. Where PG&E renews its claim of confidentiality please specify why the information cannot be provided in the format used by SCE (in other words, please specify how providing the information in the format used by SCE would raise a concern about confidentiality).
