Our preliminary EOY 2010 Supplier Diversity performance forecast indicates we will achieve 33.4% diversity spend. While the spend is subject to audit of sub-contract results, we expect to exceed the very challenging company Supplier Diversity goal of 30%. In addition, every LOB met or exceeded their annual goal as you will see in the attachment below; and equally as impressive is that supplier diversity initiatives also contributed to reducing our total supplier costs by \$180M.
