I did a little more digging on this issue and think a supplement might actually be the best way to go. The AMF calculation we submitted with the advice letter reflected 60 MW only. We did not include the documentation for the AMF calculation for 100 MW, but we did include the resulting higher payments in appendix D. We also included a rate impact calculation for both 60 MW and 100 MW. At a minimum, we will have a to provide you with the new AMF documentation.

Also, I am checking in on whether enXco is obligated to the lower contract price now that there is an extension of the ITC grant. If this is the case, we will include as well.

We will start working on the supplement.
