**MOTION FOR PARTY STATUS OF PILOT POWER GROUP, INC.**

Pilot Power Group, Inc., (“Pilot”) respectfully moves for party status in this proceeding in accordance with Section 1.4 of the California Public Utilities Commission’s Rules of Practice and Procedure.

**I. DESCRIPTION OF PILOT**

Pilot is a privately held California corporation based in San Diego. Pilot is licensed as an electrical service provider (“ESP”) purchasing electricity and reselling it to large retail and industrial customers. Pilot has a limited number of customers, none of which are residential.

**II. PILOT’S INTEREST IN THIS PROCEEDING**

Pilot has participated in workshops called for in the November 22, 2010 Assigned Commissioner's Ruling Adopting Amended Scoping Memo and Schedule in this proceeding. This motion is filed by Pilot in order to file briefs, comments and replies to the workshops as the legal issues therein are relevant because they relate directly to potential significant negative impacts on Pilot’s ability to do business as an ESP in California, particularly with respect to the financial security requirements, and also to ensure that opportunities for retail competition in the provision of electricity through direct access is not foreclosed. In addition to filing briefs, comments and replies, Pilot contemplates otherwise participating appropriately as an active party in this proceeding. Pilot’s interests are not represented by any party to this proceeding, and its comments and brief are directly

relevant to the issues raised by the Workshop.




