APPLICATION 09-12-002**

Pursuant to Rule 11.1 of the California Public Utilities Commission's ("Commission") Rules of Practice and Procedure, Pacific Gas and Electric Company ("PG&E") respectfully moves to withdraw Application 09-12-002 ("Application"), filed with the Commission on December 3, 2009, in which PG&E requests Commission authorization to acquire, develop and construct the Manzanita Wind Project ("Project") and recover the costs of the Project in rates. In order to acquire the Project and as explained in the Application, PG&E signed a Purchase and Sale Agreement ("PSA") with Iberdrola Renewables, Inc. ("Iberdrola Renewables"), the current project owner. On January 14, 2011, Iberdrola Renewables gave PG&E notice that it was exercising its right to terminate the PSA. The termination notice is attached hereto as Appendix A. Because the PSA has been terminated and PG&E is no longer able to purchase and construct
