Hello Mary,

We met in September when the EMF Safety Network and [Redacted] came to the CPUC for a presentation to Commission staff members about our concerns regarding the SmartMeter rollout. I'm also the husband of [Redacted] who was also at the meeting and with whom you spoke about SmartMeter issues. And finally, I'm a member of the Camp Meeker Recreation and Park District Board of Directors. A year ago, the Board wrote to President Peavey about our concerns and the concerns of Camp Meeker residents about the implementation of Smart Meters in our community.

I'd like your help in finding out how the SmartMeter infrastructure (repeaters, collectors, and other non-meter elements of the mesh network) are to be installed in Camp Meeker.

The reason for my request is that it seems that Wellington/P&G&E is now installing SmartMeters in our area of Sonoma County--or at least is likely to do so in the near future. Since the issues that concern residents of Camp Meeker have not been resolved, I want residents to be informed about what is happening in their community and enable them to take appropriate actions with regard to infrastructure devices that might be installed close to their home. My hope is that, knowing where Wellington/P&G&E intends to install these devices, concerned Camp Meeker residents can use your office to mediate with Wellington/P&G&E in altering those placements.

I would appreciate some of your time to discuss this matter with you further. Please let me know of a convenient time when I may call you.
