It went as well as it could. I am going to send out a summary in the morning.

Relevant to the PUC, there was some discussion around core vs non-core customers and hospitals specifically that may not have back up power sources. She asked for a list of non-core hospitals. We indicated that wouldn't be possible as customer information is confidential. She replied that if we won't share it, she will have the PUC make us share it with her. After the meeting, we explained to her chief of staff the issues around this confidentiality in more detail and why it is problematic - and the COS promised to discuss it with her and try to get her to back off of that.

However, there may be some interest on the Congresswoman's part in the future to have the PUC enforce the non-core customers to have that back up generation in place.
